

Focus announces the acquisition financing secured by Current Solutions for Koalaty

Current Solutions LLC, a maker of electrotherapy devices doing business as Koalaty Products, has raised a total of \$4.1 million in financing for the acquisition of the Company. The Company's line of electrical stimulation products are used for pain management, rehabilitation and physical therapy.

The acquisition was lead by Glynn Bloomquist who previously headed Barton Medical Corp., an Austin, Texas-based maker of patient assist devices, until its acquisition in January 2008 by Human Care HC AB of Sweden. He said he had been looking for a new company to work with, so earlier this year assembled a group of Texas business executives and last month formed Current Solutions to acquire the Tampa company.

Les Alexander, senior vice president at Advantage Capital, said the company will benefit from a seasoned executive like Bloomquist at the helm. "The founder of Koalaty had a great business," he said. "It's just that Glynn and his group had a lot of experience growing companies like this both domestically and internationally."

Bloomquist stated that "the team at Focus Strategies Investment Banking added a lot of value in getting the transaction successfully closed. Not only were they helpful with financial modeling and strategic advice while navigating the acquisition, but were also creative and resourceful in securing \$3.3 million of non-conventional

financing during a difficult economic time.
